

Aims & objectives of the Anti-Ragging cell:


- To implement Anti-ragging regulations of UGC.

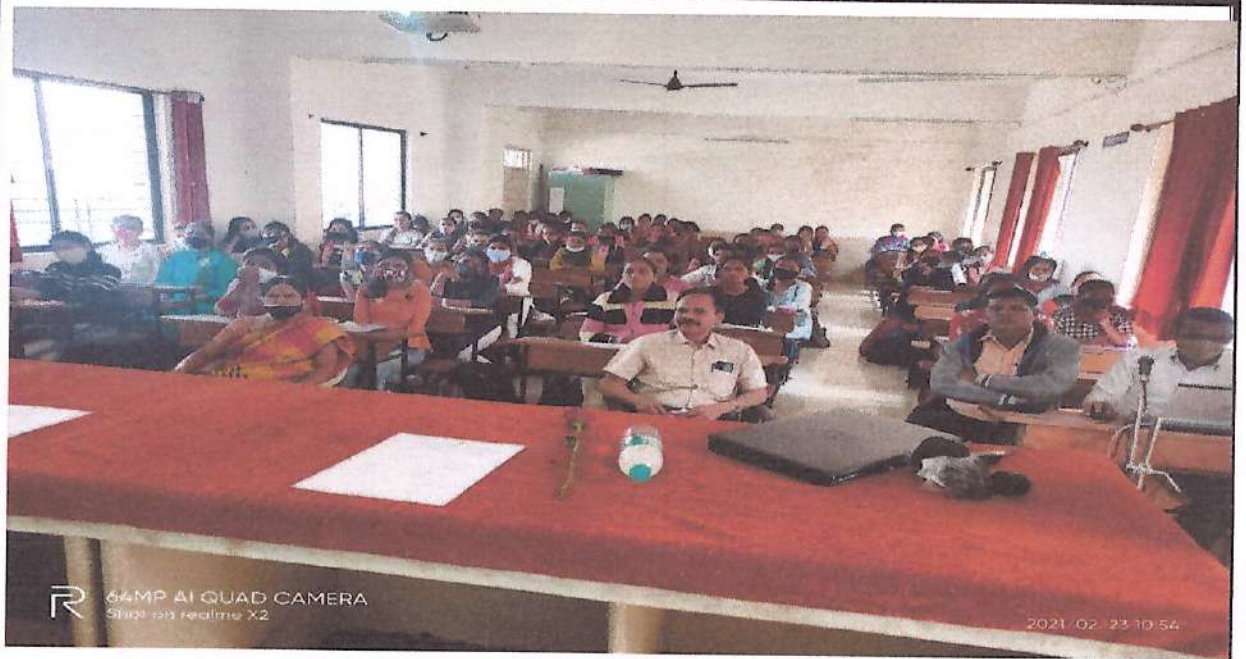


