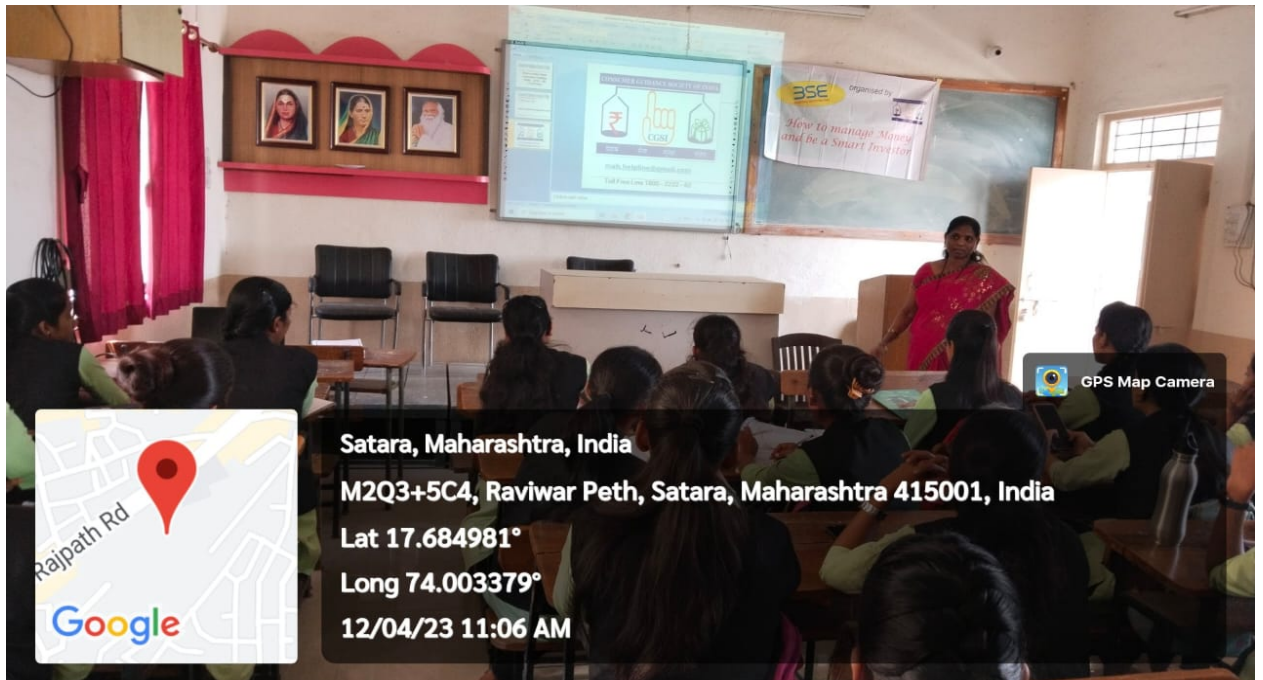

- Students came to know how to handle the grievances of investors regarding stock market investment.

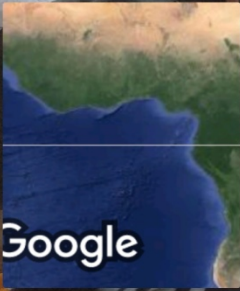

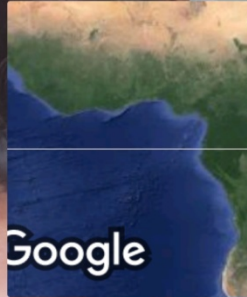
